Hello. My name is **Exercise**. I am a Chinese citizen from Shanghai. I have been in the United States for four months. About myself, I am a professional actress in China. For more than a decade, I've appeared in and starred in TV shows and commercials in China. I am currently visiting the U.S. and holding a B1/B2 visa and would like your permission to change my visa to F-1 student.

I entered the U.S. in a non-student status in the beginning of February The original intended stay was approximately for 40 days. During this time I was here originally to study for roles in China that required some knowledge of the U.S. and U.S. culture. However my study for these roles was cut short due to the COVID-19 pandemic.

Further, I realized that the best way to better prepare for these roles was to actually improve my English skills so I can better understand my parts and bring a level of authenticity to them in my career.

I was graduated in China Central Drama College for performing arts and am an actress in TV, Movies and TV commercial industries for more than a decade.

However as my career has improved in China, I think I will be able to get better roles and improve my career even further if I have some English skills. To improve my English level, I applied to Poly Languages Institute at Irvine subsequently and was admitted for ESL study. This is a big career risk I am taking, setting aside two years to study to improve my career. Once I complete my studies, I will return to China and be with my two daughters and use my new skills to improve my career.

As I intend to enroll full-time ESL classes in 2020, I do not wish to leave the U.S. at the present time to get a new VISA, so I am changing my status under the circumstances that I would suffer the following hardship(s): The flights to China are not available for coming months unless I take a charter flight that costs more than USD \$40,000.- one way. Further I may not be allowed to even enter China due to the COVID outbreak. Finally, the high risk of travel these days is another reason why I would rather do the change of status process here in the US.
